Enhancing the pharmacy provider website provides oral compound authorizations in real-time to better meet your needs

Alberta Blue Cross® is committed to continuing to enhance self-serve functionality on our secure pharmacy provider website. In October 2020, we introduced the ability to submit topical compound authorizations through our website. Based on your feedback, this process saves time during claim submissions while also reducing time spent on the phone. We are excited to announce that effective **February 22**, 2023, simple oral compound authorizations with a single final strength where the directions for use are not a dose range can be submitted through the website.

Simply visit our pharmacy provider site at <u>ab.bluecross.ca/providers/pharmacy-secure-online-site.php</u> to log in, then click the **Pharmacy claims** drop-down menu and select **Compound authorization**.



Once you input the information required, a response will be sent back in near real-time regarding the compound authorization.

Pharmacies will need to continue to call the Provider Relations Contact Centre for authorization of oral compounds where

- there is a dose range (e.g., directions for use indicate 1–2 capsules twice daily);
- there are multiple active ingredients resulting in multiple final strengths (e.g., for mouthwashes such as Dr. Akabutu's); and
- the request to compound is due to a product shortage.

If you are compounding due to a medical reason, please use the checkbox to indicate compounding due to a medical reason. The compound will be pended for further review, and a Provider Relations Contact Centre representative will call back to review the assessment within one business day.
