- 25 new COVID deaths (*but only 15 reported on the dashboard – 5,803 to 5,818*).

- 11 'reclassifications'.
 - COVID confirmed deaths that are no longer reported as a COVID deaths in the public data. These 'reclassifications' go back as far as 660, 545 and 241 days ago. This was something we often saw in the now recently deleted download file. However, this tactic to manipulate data has been moved to the main 'Severe Outcomes' chart.

- AZ and Janssen still given in Alberta.
 - AZ and Janssen are still regularly given in Alberta. Since Danielle Smith was elected, there have been 1,460 doses of AZ and 4,735 doses of Janssen. As Janssen is a double-strength single dose, this is the equivalent of 10,930 doses of COVID vaccines which have not been available in most countries due to their high-risk profile since April 2021.

- **96.98%** of Albertans are currently considered 'under-vaccinated' and thus would be ineligible for a transplant (under the criteria used for Sheila Annette Lewis).

And finally

- **30,444** 'primary series' (doses 1 & 2) vanished from the published Alberta Health data without explanation in the June 19th, 2023 update. In this week's update, Alberta Health added 11,082 but still no explanation for the missing (deleted) doses.

In the June 19th update;

- Dose 1 reduced by **15,726**.
- Dose 2 reduced by **14,718**.

Total unexplained missing 'primary series': **30,444**.

In a province looking at about 15,000 excess deaths this year, 15,000 vaccination records disappearing without explanation needs addressing.

Add this to the recently deleted Case and Death data (from the Alberta Health website -

<https://www.alberta.ca/data/stats/covid-19-alberta-statistics-data.csv>). Tag on the sudden reporting of 4,335 Janssen doses in 1 week (week of June 12th), which was clearly a deliberate delay in reporting until after the election. Consider also that this one addition of 4,335 doses accounts for 30% of all Janssen doses given in Alberta. There are a growing number of questions in the manipulation of public information that is required to be relied upon for Informed Consent.

Excess Deaths – literally off the charts.

If this had been 2020, we would have had hourly updates with these figures! Instead, we have silence.

Alberta – Population 4.3 million

625 more deaths were reported in the first **18 weeks** of 2020 than in 2019.

However, we have **2,090** more deaths reported in the comparable period in 2023.

Nearly **THREE AND A HALF** times as many people died in 2023 already.

BC – Population 5.3 million

315 more deaths were reported in the first **18 weeks** of 2020 than in 2019.

However, we have **1,895** more deaths reported in the comparable period in 2023.

Over **SIX times** as many people died in 2023 already.

Saskatchewan – Population 1.17 million

50 more deaths were reported in the first **13 weeks** of 2020 than in 2019.

However, we have **460** more deaths reported in the comparable period in 2023.

Over **NINE times** as many people died in 2023 already.

Premier Smith, did any of this come up in your recent meetings with the other Premiers? If not, why not?

Combined with everything else we know about the data manipulation and lies, I have to ask why we still have no criminal investigation started. I can't even get a reply to my emails. That speaks volumes about clear mens rea and malice aforethought in these actus reus.

Why is it that AHS still has daily reporting of cases, hospitalizations and deaths by vaccine status, but that continues to be hidden, along with so much other critical information, from the Alberta public?

Transparency and action are the minimum everyone should be demanding.

The Premier, Ministers, MLA's, AHS and Media have refused to answer to this point. Will you answer this time?

The OAG says he only reports to the Legislature. The Ombudsman and Health Quality Council say this is not their problem. <https://dksdata.com/Court/LettertoOAGandOmbudsnamOfficeJuly182023.pdf>. Even though these responses are a clear dereliction of the office and duties these people are bound by, it appears it is back to you as politicians to do your job.

If the government lied and people died, whose problem is that? If this continues and more people die, whose problem is that?

It is the sworn duty of every one of you to take this to the police for a full investigation, not another government cover up. With every moment you remain silent more people are at imminent risk. No matter how hard you try to remove the evidence or ignore it, this is not going away.

I will ask again for an urgent meeting confirmation and the immediate start of a full police investigation into the information presented here (as a start).

You already have the documentation relating to matters summarized below, including but not limited to;

- Illegal use of the Provincial Health Act to enact a State of Emergency.
- Deliberate misrepresentation of COVID cases, hospitalizations, ICU and deaths to support an unlawful State of Emergency and subsequent impacts on the citizens of Alberta. (Confirmed by Minister Copping).
- Willful endangerment of patients and care home residents resulting in harm and death.
- Discrimination of patients, residents, Designated Support Persons, visitors and staff in Health Care and Long Term Care.
- Willful breach of Health Orders by Government officials, AHS and other parties.
- Destruction and/or manipulation of public information that is evidence of crimes.
- Misrepresentation of Vaccine Safety.
- Willful withholding of information relating to known health safety issues within Alberta.
- Providing vaccinations without informed consent.
- Swapping vaccines without notice to the recipient.
- Providing vaccines from prefilled syringes not drawn by the person providing the vaccine.
- Modifying the date on expired vaccines at the point of injection.
- Providing vaccines to groups explicitly exempted due to guidelines issued by NACI in 2021 (after first notifying nursing staff NOT to vaccinate these groups).
- Manipulating/falsifying records relating to vaccinations, cases, hospitalizations and deaths.
- Refusal of urgent treatment for patients resulting in harm/ and or death.

- Refusal to accept reports of Vaccine Adverse Events despite a legal requirement for all suspected Adverse Events to be reported within 3 days of being aware.

Silence is not an option. It never was.

There are currently up to 4,247,796 people who are currently ineligible to receive a transplant organ in Alberta due to the modified AHS requirements, upheld by the Alberta Court of Appeal and accepted by Health Minister Jason Copping.

96% of Albertans are currently INELIGIBLE for a transplant due to being 'undervaccinated'

Population of Alberta 4,416,692 (down 3,347 since the peak in January. How?)

778,867 have had ZERO doses.

188,893 have had only 1 dose (-7,899 in the last 6 months).

1,617,528 have had only 2 doses (5,129 in the last 6 months).

672,167 have had only 3 doses (20,536 in the last 6 months).

1,159,237 Albertans have had 4 doses (168,896 in the last 6 months).

3,637,825 Albertans have had 1 or more doses (186,662 in the last 6 months).

96% of Albertans are currently INELIGIBLE for a transplant due to being 'undervaccinated'

There are currently 778,867 people in Alberta that have had zero doses of the COVID vaccine, leaving at least 3,448,932 people who THINK they are vaccinated and eligible for a transplant, but are not currently vaccinated enough. Currently eligible vaccinated Albertan's (by vaccination status) could be as low as 168,896 out of a population of 4,416,692. Be careful what you wish for. You just might be signing you own death certificate.
