As of April 16th. 3,186 reported deaths out of 86,080 adverse reactions reported for JUST COVID Vaccines. This is up from data just looking at 2021 in the initial table I sent.

In the UK.

Although it is reported that 33 million people in the UK have been vaccinated (by April 26th, 2021), only 12 million have had the second dose. The second dose in trials caused the most severe reactions.

Again, adverse side effects in the UK (like the VAERS system in the US) are heavily underreported.

However, compared to all vaccinations in prior years, the COVID vaccines are seeing almost unbelievable reports of short term death and adverse reactions. From the Oxford Vaccine Group in the UK in 2019.
